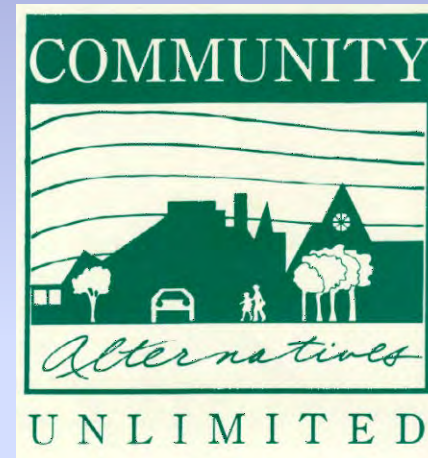

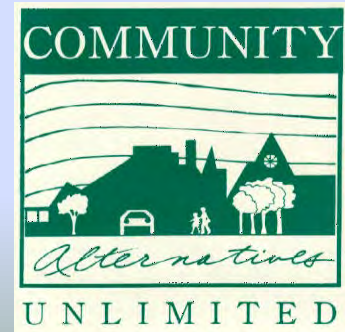

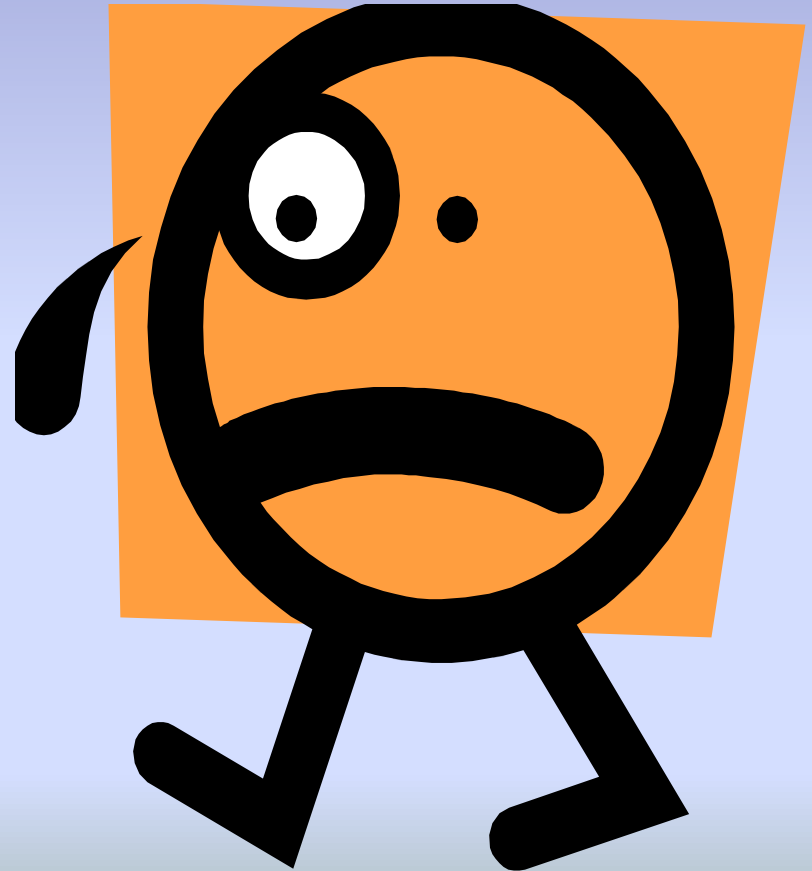
- **FIRST FREESTANDING CASE COORDINATION AGENCY IN THE STATE OF ILLINOIS**

DEFINITION & FUNCTIONS OF CASEMANAGEMENT

CASEMANAGEMENT EXISTS WITHIN A WIDE VARIETY OF ORGANIZATIONS. FUNDAMENTALLY, IT IS A COLLABORATIVE PROCESS THAT ATTEMPTS TO ACHIEVE MULTIPLE OUTCOMES, INCLUDING QUALITY CARE, COST CONTAINMENT AND CONSUMER EMPOWERMENT.



THE PROCESS OF CASEMANAGEMENT IS:

1. **ASSESSMENT** OF INDIVIDUAL NEEDS
2. **DEVELOPMENT** OF INDIVIDUAL SERVICE PLANS (ISP), DISCOVERY & PERSONAL PLAN (PP)
3. **FACILITATION/IMPLEMENTATION/COORDINATION** OF SERVICES
4. **MONITORING** AND **EVALUATION** OF SERVICE OUTCOMES
5. **DOCUMENTATION** OF CLIENT ACTIVITY



TYPES OF CASEMANAGEMENT

AS IS TRUE IN MANY DISCIPLINES, THE FIELD OF CASEMANAGEMENT HAS DEVELOPED A LANGUAGE OF ITS OWN. AND AS IN OTHER DEVELOPING FIELDS, THE WORDS – AND SOMETIMES THEIR MEANINGS – TEND TO CHANGE AS SERVICE EVOLVES.

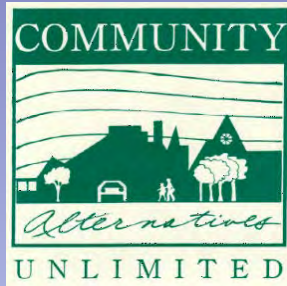
THE FOLLOWING TERMS ARE USED TO DESCRIBE THE SERVICE OF CASEMANAGEMENT AND ITS FUNCTIONS:

- **INDIVIDUAL SERVICE COORDINATION (ISC)-** *LONG TERM INTENSIVE, COMMUNITY CASEMANAGEMENT. ALSO KNOWN AS CASE COORDINATION AND SERVICE FACILITATION.*
- **PRE-ADMISSION SCREENING (PAS) AGENT-** *MANDATED CASEMANAGEMENT WITH MONITORING, FOLLOW-UP FUNCTION. PAS ASSESSMENT DETERMINES ELIGIBILITY FOR SERVICES AND NEED FOR ACTIVE TREATMENT UNDER THE IDHS DIVISION OF DD.*



POPULATION SERVED

INDIVIDUALS DIAGNOSED WITH A DEVELOPMENTAL DISABILITY (I.E. **COGNITIVE IMPAIRMENT/INTELLECTUAL DISABILITY, AUTISM, CEREBRAL PALSY, EPILEPSY**) PRIOR TO AGE 18-22 OR A **RELATED CONDITION** IF DISPLAYING SIGNIFICANT LIMITATIONS IN (3) OUT OF (6) **MAJOR LIFE AREAS**: 1) **SELF-CARE**; 2) **SELF-DIRECTION**; 3) **LANGUAGE**; 4) **LEARNING**; 5) **MOBILITY**; 6) **CAPACITY FOR INDEPENDENT LIVING** (ref. state def. MR)



ELIGIBILITY CRITERIA

INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES ARE DETERMINED ELIGIBLE FOR SERVICES BASED ON THE FOLLOWING CRITERIA:

- **PERSON IS AN ILLINOIS RESIDENT**
- **PERSON HAS A FULL SCALE IQ UNDER 70**
- **PERSON REQUIRES ACTIVE TREATMENT**
- **PERSON HAS SIGNIFICANT LIMITATIONS IN 3 OUT OF 6 MAJOR LIFE AREAS (*SELF-CARE, SELF-DIRECTION, LANGUAGE, LEARNING, MOBILITY, CAPACITY FOR INDEPENDENT LIVING*)**

ILLINOIS PRIORITIZATION OF URGENCY OF NEED FOR SERVICES (PUNS)

- PUNS IS A STATEWIDE DATABASE THAT RECORDS INFORMATION ABOUT INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES WHO ARE POTENTIALLY IN NEED OF SERVICES IN THE STATE OF ILLINOIS.
- THE STATE USES THE DATA TO SELECT INDIVIDUALS FOR SERVICES AS FUNDING BECOMES AVAILABLE, TO DEVELOP PROPOSALS AND MATERIALS FOR BUDGETING AND TO PLAN FOR FUTURE NEEDS.
- PUNS WILL BE THE TOOL THE STATE USES AS IT DECIDES WHO WILL RECEIVE SERVICES ON AN INDIVIDUAL BASIS.
- MORE IMPORTANTLY, PUNS IS NOW REQUIRED BY IDHS AS PART OF ANY FUNDING REQUEST.

ILLINOIS PRIORITIZATION OF URGENCY OF NEED FOR SERVICES (PUNS)

- PUNS IS A FACE-TO-FACE INTERVIEW BETWEEN INDIVIDUAL WITH DEVELOPMENTAL DISABILITY, GUARDIANS, PRIMARY CAREGIVERS, FAMILY AND ISC/PAS AGENCIES.
- THE ISC/PAS AGENT WILL WORK WITH THE INDIVIDUAL AND THEIR FAMILY TO IDENTIFY THE NEED FOR SERVICES, EXPLAIN SERVICES AND IDENTIFY THE URGENCY OF NEED FOR SERVICES AND WILL PUT YOUR NEED FOR SERVICES INTO ONE OF THESE CATEGORIES: SEEKING SERVICES (Person needs services within one year) or PLANNING FOR SERVICES (PERSON DOES NOT NEED SERVICES FOR AT LEAST A YEAR, OR THE CARE GIVER IS OLDER THAN 60 YEARS)
- PUNS NEEDS TO BE UPDATED ANNUALLY.
- ANYTIME A NEED FOR SERVICE CHANGES.
- WHEN CONTACT INFORMATION CHANGES, SUCH AS ADDRESS OR TELEPHONE NUMBER.
- WHEN CAREGIVER INFORMATION CHANGES.
- THE PUNS SELECTION IS AN OPEN AND FAIR PROCESS USING CRITERIA SUCH AS LENGTH OF TIME ON DATABASE, URGENCY OF NEED AND GEOGRAPHIC AREA OF THE STATE.
- PUNS SELECTIONS ARE BASED UPON FUNDING AVAILABILITY AND ABILITY TO FILL PROGRAM VACANCIES.
- INDIVIDUALS SELECTED FROM THE DATABASE WILL RECEIVE A LETTER DIRECTLY FROM THE ILLINOIS DEPARTMENT OF HUMAN SERVICES ANNOUNCING THEIR SELECTION AND INVITING THEM TO APPLY FOR SERVICES BY CONTACTING THEIR ISC/PAS AGENCY

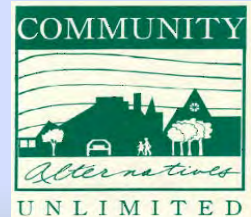

Terminology In the State of Illinois

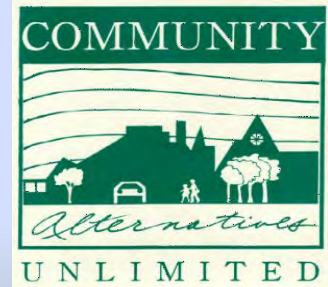
- The term developmentally disabled refers to individuals who have cognitive impairment/intellectual disability autism, cerebral palsy or epilepsy before the age of 18. cognitive impairment/intellectual disability refers to significantly sub-average general intellectual functioning existing concurrently with deficits in adaptive behavior and manifested before the age of 22 years. Significantly sub-average is defined as an intelligence quotient (IQ) of 70 or below on standardized measures of intelligence. This upper limit could be extended upward depending on the reliability of the intelligence test used.
- The term intellectual disability is defined as a condition which may prevent an individual from functioning as an independent individual due to debilitating psychological/psychiatric problems such as schizophrenia, recurrent major depression, bipolar disorders and other severe mental health conditions.

- **PSYCHIATRIC EVALUATION – IF PERSON HAS AXIS I DX**
- **RELEASES OF INFORMATION**
- **MEDICAL HISTORY & PHYSICAL EXAMINATION FORMS**
- **COPY OF SOCIAL SECURITY CARD**
- **COPY OF MEDICAID CARD**
- **COPY OF PUNS**

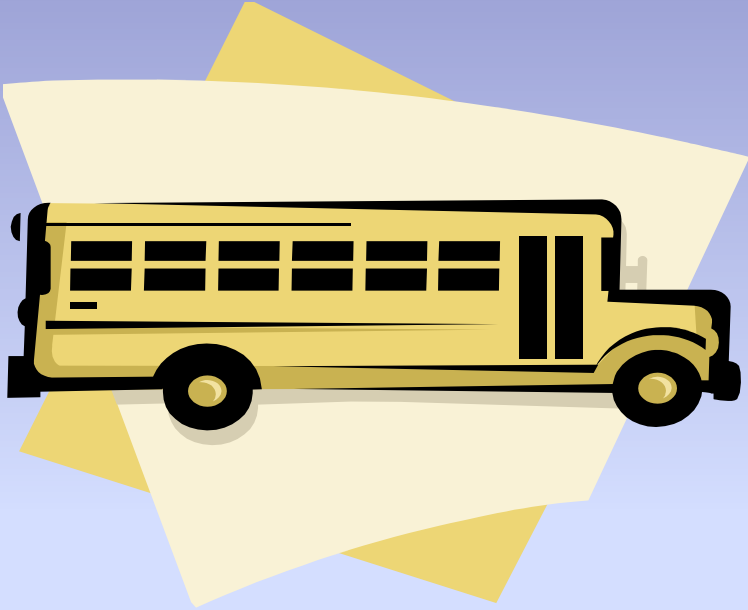

ADULT CRISIS CRITERIA AS ESTABLISHED BY IDHS-DIVISION OF DEVELOPMENTAL DISABILITIES (DDD)- see IDHS 4/16/08 MEMO

- **The Division of Developmental Disabilities is unable to provide funding for Waiver services except for individuals whose circumstances place them within one of the following CRISIS criteria categories. *PAS AGENCIES MUST NOT SUBMIT REQUESTS FOR FUNDING UNLESS THE INDIVIDUAL FITS INTO ONE OF THE FOLLOWING CATEGORIES FOR THE TYPE OF SERVICES BEING REQUESTED:***
 - A. **Residential Services (i.e. Waiver CILA-Community Integrated Living Arrangement or Waiver CLF-Community Living Facility):**
 1. **Individuals who are in crisis situations (e.g., including but not limited to, persons who have lost their caregivers, persons who are in abusive or neglectful situations; homelessness; individual's behaviors**
 2. **Individuals who are wards of the DCFS and are approaching the age of 22 and individuals who are aging out of children's residential services funded by the Office of DD;**
 3. **Individuals who reside in State-Operated Developmental Centers;**
 4. **Bogard class members, i.e., certain individuals with DD who currently reside or previously resided in a nursing facility; and**
 5. **Individuals with MR who reside in State-Operated Developmental Mental Health Hospitals.**

*****Funding requests for individuals with aging caregivers and for individuals who reside in private ICFs/MR must not be submitted unless the individual also *fits into one of the five categories listed above***

ADULT CRISIS CRITERIA AS ESTABLISHED BY IDHS-DIVISION OF DEVELOPMENTAL DISABILITIES (DDD) – SEE 4/16/08 MEMO

- ***The Division of Developmental Disabilities is unable to provide funding for Waiver services except for individuals whose circumstances place them within one of the following CRISIS criteria categories. PAS AGENCIES MUST NOT SUBMIT REQUESTS FOR FUNDING UNLESS THE INDIVIDUAL FITS INTO ONE OF THE FOLLOWING CATEGORIES FOR THE TYPE OF SERVICES BEING REQUESTED:***

B. SUPPORT SERVICES. (i.e., Adult Home-Based Services (AHBS), the individual must not be receiving any support services from the Division of Developmental Disabilities or the Division of Rehabilitation Services (except vocational rehabilitation services). Further, the individual must fit into one of the following circumstances:

- ***The death of a caregiver(s);***
 - ***The caregiver is unable to address the support needs of the individual, thereby jeopardizing the individual's health, well-being and/or safety needs;***
 - ***The physical and/or mental injury and /or sexual abuse inflicted on the individual;***
 - ***The status as a homeless/undomiciled individual;***

CHILDREN'S CRISIS CRITERIA AS ESTABLISHED BY IDHS-DIVISION OF DEVELOPMENTAL DISABILITIES (DDD) – SEE 4/16/08 MEMO

- *The Division of Developmental Disabilities is unable to provide funding for Waiver services except for individuals whose circumstances place them within one of the following CRISIS criteria categories. **PAS AGENCIES MUST NOT SUBMIT REQUESTS FOR FUNDING UNLESS THE INDIVIDUAL FITS INTO ONE OF THE FOLLOWING CATEGORIES FOR THE TYPE OF SERVICES BEING REQUESTED:***
- ***B. SUPPORT SERVICES.** (i.e., CHILDREN HOME-BASED SUPPORT (CHBS) and Children's Residential Programs (17D & 19D). The individual must **not** be receiving any support services from the Division of Developmental Disabilities or the Division of Rehabilitation Services or Division of Specialized Care for Children (DSCC) Waiver Program. Further, the individual must fit into one of the following circumstances:*
 - *The caregiver is unable to keep the child safe;*
 - *The caregiver is unable to meet the child's support needs. The family dynamics (i.e. multiple children with disabilities dependent upon the caregiver) as correlated with the medical, physical, and/or behavioral needs of the child place demands on the family that put the child and/or family member(s) at serious risk;*
 - *The child's behaviors (i.e. verbal and/or physical aggression, bodily harm to self and/or others) put the child and/or family member(s) at risk of serious harm;*

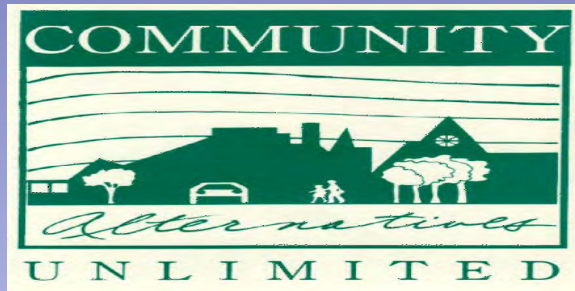
